2010 National Trucking Industry Awards



National Award for an **Outstanding Contribution** to the Australian Trucking Industry

This award recognises the commitment of an individual or an organisation to improving the trucking industry through their operation or their contribution to industry activities.

Award Selection Criteria

Nominees for this award must be an individual or a private/public sector organisation associated with the Australian trucking industry. They must demonstrate:

- Long-term participation in road transport.
- Personal and/or corporate commitment to achieving positive benefits for the industry through actions.
- A proven commitment to raising both community and industry awareness and appreciation of trucking.
- In the case of an individual, a selfless attitude which has resulted in personal cost.
- In the case of an organisation, a commitment to achieving benefits for road transport that has incurred an organisational cost.
- A demonstrated reputation for integrity and ethical behaviour in trucking.

Conditions of Entry

- 1) The award is open to any individual or organisation who/which operates full-time in the Australian trucking industry. Nominations can be made by anyone, and those wishing to nominate themselves can do so.
- 2) Entries must be submitted on the official ATA National Trucking Industry Awards Nomination Form.
- 3) The nomination information form must be completed and attached to the Awards Nomination Form.
- 4) Nominations must address all points outlined in the award criteria.
- 5) A recent good quality photograph of the nominee must be included with the nomination or emailed to the Awards Secretary.
- 6) Nominations must be received by the ATA no later than the closing date. However, late entries may be accepted but it is at the absolute discretion of the Judges.

- 7) The Judges will select one to three finalists for each award subject to the entries meeting the Judges' standards.
- 8) The Judges may choose to present 'Honourable Mentions'.
- 9) The Judges may choose not to select finalists in a category.
- 10) The Awards will be judged according to the selection criteria.
- 11) The Judges may remove a nomination from a category that they believe is ill-suited to the nomination and submit it to a different award category.
- 12) The judging panel and/or the ATA will not enter into correspondence regarding the judging process other than to advise nominees and nominators of the success or otherwise of their nomination.
- 13) Finalists receive a complimentary day registration for the Australian Trucking Convention to attend those activities aligned to the awards, which includes a complimentary ticket for the individual to attend the Awards Dinner. However, they are responsible for their own Convention registration (for days other than the day of Awards events), travel and accommodation costs and per diems. It is customary for nominators to provide the financial support for their nominees to attend the Australian Trucking Convention.
- 14) An international travel package received as a prize must be redeemed by 31 December of the award year (unless alternative arrangements are made with the award sponsor) and is not transferable.
